Per our charter company's policies: Charters cancelled within 72 hours of the scheduled departure will be charged \$32.44 per hour times the originally scheduled charter hours. Charters cancelled within 24 hours of the scheduled will be charged the full rate originally quoted.

Lenzner Mt Nebo:

Once confirmed through our office, a confirmation will be mailed and a 10% or minimum \$100.00 per vehicle deposit is to be submitted to hold the vehicle(s). Final payment is due two weeks prior to trip departure date. The cancellation policy is as follows: When the Chartering Party notifies Lenzner Coach Lines in writing of the intent to cancel the charter agreement more than twenty-one (21) days prior to departure, the full deposit amount is refundable. Should the agreement be cancelled less than twenty-one (21) days but more than seven (7) days prior to departure, then Chartering Party shall forfeit deposit amount. Should the agreement be cancelled less than seven (7) days but more than seven (72) hours prior to departure, then Chartering Party shall forfeit fifty percent (50%) of price quoted. No refund less than seventy-two (72) hours prior to departure.
